**Subject: Disclosure under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 as amended (“ SEBI Listing Regulations ”)**

Madam / Dear Sir,

Pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, a penalty of Rs. 10,66,462/- has been imposed on the Company by the State GST Tax officer, Gujarat for failure to comply with the E-way bill requirements by the Transporter under the provisions of GST Law.

Based on our assessment, we believe that the aforementioned demand would not be maintainable, and the Company is in the process of preferring appeal against the said orders.

The detailed disclosure with respect to the orders as required under the SEBI Circular SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023 is enclosed herewith as ‘Annexure – I’.
